

CRIMINAL JUSTICE - ASSOCIATE IN CRIMINAL JUSTICE

The Criminal Justice Associate degree program prepares students for a career in the multifaceted criminal justice system. The curriculum, which covers a variety of topics in criminal justice, focuses on developing the ability to recognize and apply pertinent concepts and techniques while stressing the practical skills necessary to deal with complex social, political, and organizational factors. This program is structured around core courses, allowing students to acquire the basic knowledge and skills needed to work in law enforcement, private security, corrections, probation, and other related areas of criminal justice.

The Criminal Justice Associate degree program includes the study of substantive law, criminal justice, social sciences, humanities, behavioral sciences, natural sciences, and general education courses. The degree can be applied toward a bachelor's degree in Criminal Justice or other majors at New Mexico State University.

60 credits

The Associate in Criminal Justice introduces students to three areas of the Criminal Justice system: police, courts, and corrections. This degree is interdisciplinary in nature. Studies include the humanities, law, natural, behavioral and social sciences. The curriculum seeks to balance theoretical inquiry with applied knowledge.

This Associate degree satisfies the first two years of the Distance Education Bachelor of Criminal Justice.

Students must complete all University degree requirements, which include: General Education requirements and elective credits to total at least 60 credits. Developmental coursework will not count towards the degree requirements and/or elective credits, but may be needed in order to take the necessary English and Mathematics coursework.

Note: A grade of C- or better is required in all Criminal Justice courses and any courses filling the Arts & Sciences Core Requirements.
